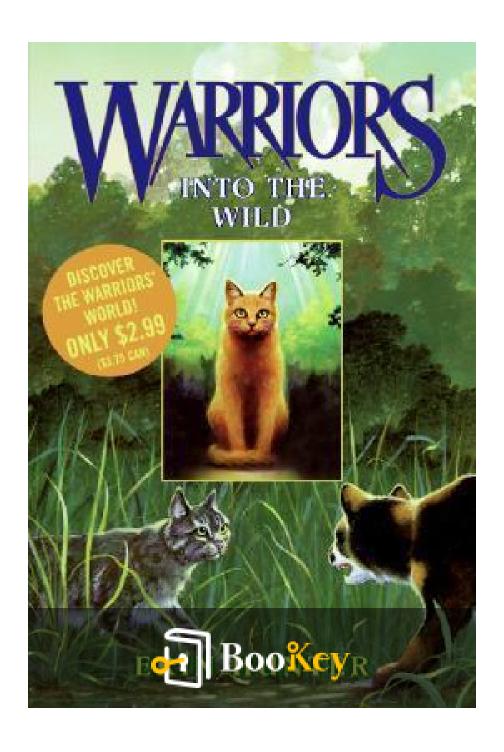

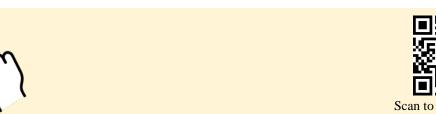

Yet, the last book he reads would also mark the turning point of his decline. After finishing the book, he records in his journal that he feels "extremely weak," which marks the beginning of a rapid deterioration in his
